**ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 21<sup>st</sup> January, 2021

**No. 2/11/Jiri Col/Conv./HE-16(b):**

Whereas, consequent upon the taking over of Jiri College, Jiribam vide Order No. 2/11/Jiri Col/Conv./HE-16 dated 08.12.2016, Finance Department (PIC) had recommended Dr. Beauty Das as Lecturer in Bengali subject in Jiri College, Jiribam under 'Unqualified Group at the time of taking over by the Government' subject to verification of SC Certificate;

2. And whereas, Appointment order was issued vide Order No. 2/11/Jiri Col/Conv./HE-16 dated 07.03.2019 for 65 teaching and 32 non-teaching staff of Jiri College, Jiribam, which did not include Dr. Beauty Das with the following clause in the aforementioned appointment Order:

*"6. The appointment orders in respect of Dr. Beauty Das, unapproved teacher in Bengali Subject shall be issued separately subject to verification and submission of Community Certificate by the Director of University & Higher Education, Manipur."*

3. And whereas, the Director of University & Higher Education, Manipur had furnished a copy of SC Certificate dated 31.07.1996 issued by the President, Asom Anusuchit Jati Parishad along with another SC Certificate dated 15.11.2018 issued by the Chairman, Sub-Divisional SC Dev. Board, Silchar, Cachar wherein it is stated that Dr. Beauty Das belongs to '**Kalibarta**' Community;

4. And whereas, the Additional Deputy Commissioner, Cachar, Silchar vide letter dated 15.04.2019 has also stated that the sub-caste 'Kalibarta' is recognised as SC by the Govt. of Assam;

5. And whereas, the Director of Other Backward Classes & SC's, Imphal vide letter No. 1/C-DD/2018-MOBC&SC dated 30.07.2019 has also stated that the Sub-Caste 'Kalibarta' does not find a place in the SC list in the State of Manipur;

6. And whereas, the Director (UHE), Manipur vide letter No. 3/3-582/90-EDC(Pt-II) dated 14.08.2020 has also reported the following:

- i. Beauty Das was appointed as Lecturer in Bengali without mention of any caste Category by the Governing Body of Jiri College, Jiribam vide Order No. 22/JC/Secy./GB/93(1) dated 15.01.2014;
- ii. She is qualified as per UGC Rule under SC category and not qualified if considered under UR Category.

7. And whereas, since the sub-caste 'Kalibarta' is recognised as SC by the Government of Assam but not recognised in the State of Manipur, views of FD (PIC) was sought for as FD(PIC) had initially concurred to the appointment of Dr. Beauty Das as 'Lecturer in Bengali of Jiri College', Jiribam subject to verification of SC certificate, on whether Dr. Beauty Das may be appointed as Lecturer in Bengali subject in Jiri College, Jiribam under 'General' Category;

8. And whereas, views of Finance Department (PIC) has been obtained, the same of which is reproduced below:

*"As per report of Verification of SC Certificate, Finance Department (PIC) have no objection to the issuance of absorption/appointment order in respect of Dr. Beauty Das as Lecturer in Bengali of erstwhile Jiri Govt. Aided College (now full-fledged Govt. College), Jiribam (un-qualified at the time of taking over by the Government) under general/un reserved category."*

9. Now therefore, the Governor of Manipur is pleased to order the appointment of Dr. Beauty Das as Lecturer in Bengali in Jiri College, Jiribam (un-qualified at the time of taking over by the Government) under general/un-reserved category in the Pay scale of Rs. 9300 - 34800 + GP Rs. 4400.

10. This is issued in consultation with the Finance Department (PIC).
