**No. 14(9)/6/2019-HE(B)(CONVSN):** Whereas, consequent upon the taking over of 6 Aided Colleges namely, (1) Biramangol College, Sawombung, (2) Kakching Khunou College, Kakching Khunou, (3) Liberal College, Luwangsangbam, (4) Mayai Lambi College, Yumnam Huidrom, (5) Standard College, Kongba, (6) Thambal Marik College, Oinam and another one Jiri College, Jiribam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018 and No. 2/11/Jiri Col/Cov./HE-16 dated 08.12.2016 respectively, the Administrative Department had appointed 478 (four hundred and seventy eight) numbers of teaching staff and 163 (one hundred and sixty three) numbers of non-teaching staff of the erstwhile 6 (six) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 and also appointed 65 (Sixty-five) numbers of teaching staff and 32 (thirty-two) numbers of non-teaching staff of the erstwhile Jiri Aided Colleges, Jiribam into Government service vide Government Order No. 2/11/Jiri Col/Conv./HE-16 dated 07.03.2019 with due concurrence of Finance Department (PIC);

2. and whereas, the Director, University & Higher Education, Manipur vide their letter No. 3/3-36/15-UHE(Pt-I) dated 23.09.2020 had furnished the re-verification report of the Verification Committee regarding the rectification of status of qualification in respect of 3 (three) teaching staff of aforesaid erstwhile Aided Colleges who were initially appointed as 'Lecturer' under the category 'Unqualified (Unapproved)' group vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 and No. 2/11/Jiri Col/Conv./HE-16 dated 07.03.2019;

3. and whereas, in pursuance of Cabinet decision taken on 20.04.2020 and as concurred by the Finance Department (PIC), the Administrative Department of Higher & Technical Education, Manipur vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(EIN) dated 27.05.2020 had created 71 nos. of supernumerary post of Lecturers in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- and fit the unqualified teachers, **including the 3 (three) teaching staff mentioned at Para 2 above**, of erstwhile Aided Colleges in the newly created posts subject to the following conditions:

- i) To freeze the 71 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite education qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.
- iii) The Lecturers who are not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 -
